94-32 No person, which shall be defined to include a family unit, and no owner, as that term is defined in § <u>94-1</u> of this chapter, shall keep, harbor or have possession or custody of more than four dogs on any one residential premises within the Township except as otherwise permitted by local ordinances. This restriction shall not include the temporary keeping of puppies for a maximum period of 90 days which have been borne to a female dog kept on the premises at the time of birth of said puppies.
