He explained that Administration has recently received a water bill from Pemberton Borough which represents a substantial increase than what was anticipated. Pemberton Borough has been questioned, and they explained they have not been charging the contracted rate. Administration is currently investigating that to determine what the rate was that they were charging and why the increase. The Mayor informed that some adjustments have been made in the Water Department budget and distributed the revised budget sheets to Council. Mayor Patriarca explained the adjustments and advised that the changes do not change the bottom line in that department.
