WHEREAS, THE WIND SHIFT EXPOSED PROBLEMS AT THE TRACK 70 COMPLEX WHERE CHIEF AUGUSTONI ESTABLISHED A COMMAND POST WHERE PRESIDENTIAL LAKES WATER TENDER AND A UNIT FROM LEBANON LAKES WERE, AS THE TEAMS WERE NOT ONLY PERFORMING STRUCTURAL PROTECTION BUT ALSO SUPPORTING THE FOREST FIRE UNITS AS THEY PROTECTED THE STRUCTURES NAME ACTIVATED AND LIBERAL AND LIBERAL AND LIBERAL MADE ACTIVATED MILITIAL MADE ACTIVATED MILITIAL AND LIBERAL MADE ACTIVATED MILITIAL MADE ACTIVATED MADE ACTIV

ON MAY 9TH THERE WAS 100% CONTAINMENT AS THE PEMBERTON TOWNSHIP FIRE DEPARTMENT PERSONNEL REMAINED ON LOCATION FOR A TOTAL OF 24 HOURS CONDUCTING PATROLS AROUND SENECA AND RED FEATHER REASSURING THE RESIDENTS AND ENSURING IF THERE WERE ANY FIRES THEY WOULD NOT GET OUT OF CONTROL AND OFFERING SUPPORT TO THE NJ FOREST FIRE SERVICE; AND

WHEREAS, WITH 487 ACRES WHICH WERE BURNED DURING THE PEAK OF THE FIRE AND THE FIFTY PLUS HOMES THAT WERE IN DANGER, THERE WERE APPROXIMATELY 46 PEMBERTON TOWNSHIP FIRE DEPARTMENT PERSONNEL WHO EXPENDED APPROXIMATELY 1138 MAN HOURS, 24 FIRE STATIONS AND 9 EMS WERE DISPATCHED INCLUDING TWO COMPANIES OUT OF OCEAN COUNTY AND 2 BURLINGTON COUNTY FIRE POLICE TEAMS, THE NJ FOREST FIRE SERVICE, THE NJ STATE POLICE, PEMBERTON TOWNSHIP POLICE, BURLINGTON COUNTY OFFICE OF EMERGENCY MANAGEMENT, BURLINGTON COUNTY FIRE COORDINATOR'S OFFICE, NJ DIVISION OF FIRE SAFETY AND THE NJ DEPARTMENT OF TRANSPORTATION WHICH ALL ASSISTED, ALONG WITH THE CONTRIBUTING MEMBERS OF COUNTRY LAKES FIRE COMPANY, BUSINESS ADMINISTRATOR CHRIS VAZ, AS WELL AS RESIDENTS THAT OFFERED SUPPORT THROUGH THE PROVISION OF FOOD AND WATER TO THE CREWS

GENERAL PUBLIC COMMENTS:

Council President Scull opened the meeting to general public comments. Those indicating a desire to be heard were: **Charles Jenkins:** Expressed his unhappiness that his grandchildren were not allowed to march in the Memorial Day Parade. The Mayor and Council President Scull informed Mr. Jenkins that it was the Veteran's Committee that made the decision. John Shaw: Commented that baseball kids are part of the military families of town. Stated Mr. Emmons was at the parade to hand out water and not for politicking. The Lions Club is a non-political function. Kathy Sheridin: Commented on an ongoing problem in Lake Valley Acres of brush lying on the streets for months. Mayor Patriarca informed brush pick up started this week in Lake Valley Acres. Ms. Sheridin questioned the lack of manpower. Mayor Patriarca explained manpower has been diverted to other projects that normally would have been contracted out. Mr. Vaz provided a break down of pending Public Works' service calls within the Township. Mr. Vaz noted there are also quite a few workers out on workers compensation leave of absences. America Phillips: Appreciated the clean up in Presidential Lakes. She expressed that everyone should be able to participate in the Veterans Parade. She reported that a home at 200 New Hampshire Road that borders her property which has been empty since June 12, 2009, and has not been maintained. She asked why they have not received a summons. Mayor Patriarca replied Code Enforcement will be there tomorrow. Mrs. Phillips reminded she has spoken of 325 North Carolina and New York Road many times. She spoke of residents on Tennessee Trail that cannot get to their mailboxes when it rains and asked for drainage to be installed on Tennessee Trail. She thanked the Township for the port-a-pot installed for the children and noted that a handicapped toilet is also needed. She informed that intersection of Tennessee Trail and New York Road has no visibility due to the trees. **John Shaw:** Asked when the grass at the library will be cut. The Mayor advised it will be taken care of. Michelle Forman: Commented on the brush piles in Lake Valley Acres. She expressed she is very proud of the Mayor and Business Administrator for Imagination Kingdom. She noted seeying the Jenkins everywhere in the Township. She asked if the police officers and employees that work outdoors have pamphlets that educate them on skin cancer. Mr. Vaz informed employees are trained through the joint insurance fund. Noted that Mr. and Mrs. Jenkins were at Pemberton Idol at the high school. There being no additional members of the public indicating a desire to be heard, Council President Scull closed the meeting to public comments.

Andy Bayer: 1. No report for the public.

ENGINEER'S REPORT:

Brett Ingram: 1. A.C. Schultes has been working on the well. Mr. Prickett asked about the water tower at Oak Pines that has algae eating away at the paint. Noted the problems with the Lake Valley water system that are hopefully being addressed. Mr. Ingram replied he will look in to it.

MAYOR'S REPORT:

David Patriarca: 1. Working on building improvements at the municipal building by replacing ceiling tiles and lighting in the hallways. Attended an awards dinner in Atlantic City where Clean Communities Chairperson Dawn Hullings received an award for her programs in the Township.

COUNCIL MEMBERS' COMMENTS:

Diane Stinney: 1. Thanked everyone for coming out.

Mr. Prickett spoke of fallen trees throughout the Township and the safety hazards associated with that. Asked Mr. Vaz if the safety hazards are being addressed. Mr. Vaz explained Public Works' process for receiving service requests, and they prioritize the requests received.

Diane Stinney (continued): 2. Thanked everyone for their comments and concerns. Wished everyone a good evening.

Rick Prickett: 1. Saddened to hear about the children that were not able to take part in the Memorial Day ceremony. Noticed there were not a lot of children at the parade. The Commander welcomed children to the ceremony and spoke of an education moment. If children don't learn what the meaning of Memorial Day is by being at Memorial Day, hopefully they don't learn about through injuries and deaths in their families. Children should be part of Memorial Day and the Commander was intoned to that and was giving instructions that the children should be quiet, remain polite and attentive and listen carefully to what was being talked about. When we don't have children present at different functions, we are the losers because all of us old people at these affairs and the kids are disconnected. It was a beautiful ceremony. **2.** The Soroptomist had a beautiful ceremony with the mosaics in the gazebo. **3.** Clean Communities was cleaning up the lake and also took part in the Soroptomist gazebo mosaic affair. **4.** Noted the Blueberry Festival is coming up on June 26th. Hopes to see everyone there. **5.** Wished everyone a good night.

Ken Cartier: 1. Thanked everyone for coming out. Wished everyone a safe trip home.

Tom Inge: 1. Thanked everyone for coming out. **2.** Thanked Charlie Jenkins for coming forward this evening and expressing his feelings about his grandchildren not being able to march in the parade. We have to think back when the parade was

very small, baseball players did participate in the parade. They should continue to participate in the parades in the future in the Township. **3.** Wished everyone a safe trip home.

Sherry Scull: 1. Informed that Mr. Harold Cathers passed away, and his viewing is this evening. Mr. Cathers was a residents for 49 years, a veteran of WWII and the Korean War. 2. Thanked Mrs. Forman for mentioning Imagination Kingdom. It makes her very happy when she rides by and sees their residents using the playground. It is such a great community effort. 3. Attended the Country Lakes Community Center opening. She noted the employees have done a wonderful job renovating the building. They are still working on the exterior. There will be a grand opening in June for the Dominique Johnson Center. It makes her feel very proud that they have been able to renovate their buildings. It is a smart way to save taxpayer's money. 4. Agrees with Ms. Sheridin in that she doesn't like seeing the brush either. She has called the Mayor several times and is glad to hear they are starting on brush. 5. Have received up to 1300 responses for the Browns Mills survey. The last day for responses is Monday. A lot of school employees have stated to her that they are happy they were included. Many of them even though they don't live here do spend a lot of their money in their community and different businesses. Hopefully that will help the company draw in some businesses that will benefit everyone. 6. She was very sad when she didn't see the parents bring their children out to the Memorial Day parade. She expressed if they were willing to bring the children to march, they should have been willing to bring the children to participate in the Memorial. She stated that they have to remember what Memorial Day is about and unfortunately their country gets away too much with that. It's not just the beginning of summer and it's not just about having a parade or having a picnic. Mrs. Scull reiterated that it bothers her if the parents were willing to bring the children to the parade and when they can't march then they don't take them and what kind of message does that give those children. She expressed the need to teach the children about those who gave their lives which is what should be important on Memorial Day. 7. Wished everyone a good evening and thanked everyone for coming out.
