**AN ORDINANCE ESTABLISHING SALARIES, COMPENSATION AND BENEFITS
WITHIN THE TOWNSHIP OF PEMBERTON.**

BE IT ORDAINED AND ENACTED, by the governing body of the Township of Pemberton, County of Burlington, and State of New Jersey as follows:

Ordinances No. 11-2010, 16-2010, 1-2011, and 6-2013 are hereby amended and supplemented as follows:

ARTICLE I. ESTABLISHMENT OF SALARIES.

The following base salary ranges are hereby established in the following positions within the Township of Pemberton.

ARTICLE II. INCORPORATION OF BALANCE OF ORDINANCE 10-1994.

The balance of Ordinance 10-1994, in so long as it is related to additional benefits (including, but not limited to, hospitalization/medical benefits, longevity pay, educational training, etc.) are incorporated herein at length, are saved from repeal, and shall be continued in their entirety; except hospitalization/medical benefits and/or the \$3,000.00 annual stipend in lieu of hospitalization/medical benefits shall be provided to employees who work a minimum of 26 hours per week; and Township Council Members shall receive hospitalization/medical benefits or the \$3,000.00 annual stipend in lieu of said benefits. The Chief of Police shall not be entitled to any longevity pay, clothing and weapons allowance. Positions covered under this ordinance shall only be entitled to sick time sell back options at levels that are provided to employees under the Township's CWA agreement.

ARTICLE III. REPEALER/INCONSISTENCY/EFFECTIVE DATE.

Any and all ordinances inconsistent with the provisions of this ordinance are, to the extent of such inconsistencies, hereby repealed.
