

**TOWNSHIP OF PEMBERTON**

**AN ORDINANCE OF THE TOWNSHIP OF PEMBERTON  
AMENDING CHAPTER 147 OF THE CODE OF THE  
TOWNSHIP OF PEMBERTON, ENTITLED 'RECYCLING'**

**ORDINANCE NO. 11- 2018**

**WHEREAS**, the purpose of this ordinance is to regulate the placement and/or storage of recycling containers on private property so as to prevent spills and discharges, and to declare that the placement of recycling containers on or near a public rights of way constitutes a public nuisance.

**NOW, THEREFORE, IT IS ORDAINED** that Chapter 147-6 (E) is hereby amended in its entirety as set forth herein.

E. (1) Recycling shall be placed roadside or curbside by the beginning of the scheduled collection day as published on the Township website but not prior to 4:00 p.m. of the day preceding the day of collection, and shall be removed no later than the day of collection.

(2) Except as specifically permitted for collection, no occupant shall store or maintain recycling containers in the front yard area. The violation of this provision shall constitute a public nuisance, and is necessary for the preservation of the public health, safety and general welfare.

**IT IS FURTHER ORDAINED** that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

**IT IS FURTHER ORDAINED** that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

**IT IS FURTHER ORDAINED** that this Ordinance shall take effect upon passage and publication in accordance with applicable law.
