TOWNSHIP OF PEMBERTON ORDINANCE NO. 12-2014

AN ORDINANCE OF THE TOWNSHIP OF PEMBERTON AUTHORIZING THE SALE OF A K-9 CAGE NO LONGER NEED FOR PUBLIC USE BY THE TOWNSHIP TO THE LUMBERTON POLICE DEPARTMENT FOR NOMINAL CONSIDERATION

WHEREAS, pursuant to the Local Lands and Buildings Law (N.J.S.A. 40A:12-1 et seq.) the Township of Pemberton (the "Township") is permitted to sell any real or personal property no longer needed for public use at private sale to any political subdivision, agency, department, commission, board or body corporate and politic of the State of New Jersey; and

WHEREAS, the Pemberton Township Police Department is in possession of a K-9 cage which is designed for the backseat of a Crown Victoria Police Interceptor, which has been in storage for several years and is no longer needed for use by the Pemberton Township Police Department; and

WHEREAS, the Lumberton Township Police Department is desirous of acquiring the K-9 cage for use as part of its canine program; and

WHEREAS, the Township desires to sell the K-9 cage which is no longer needed for public use by the Pemberton Township Police Department to the Lumberton Township Police Department for nominal consideration.

NOW, THEREFORE, BE AND IT IS HEREBY ORDAINED, by the Township Council of the Township of Pemberton, County of Burlington and State of New Jersey, that the sale of the Pemberton Township Police Department's K-9 cage to the Lumberton Police Department for nominal consideration is hereby approved and that the Mayor is hereby authorized to execute any and all necessary documents required to effectuate the transfer of the property in forms acceptable to and approved by the Township Solicitor.

BE IT FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

BE IT FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

BE IT FURTHER ORDAINED, that this Ordinance shall take effect upon passage and publication in accordance with applicable law.
