**AN ORDINANCE OF THE TOWNSHIP OF PEMBERTON
AMENDING CHAPTER 152 OF THE CODE OF THE
TOWNSHIP OF PEMBERTON, ENTITLED 'SOLID WASTE'**

ORDINANCE NO. 12- 2018

WHEREAS, the purpose of this ordinance is to regulate the placement and/or storage of solid waste and/or refuse containers on private property so as to prevent spills and discharges, and to declare that the placement of solid waste containers on or near a public rights of way constitutes a public nuisance.

NOW, THEREFORE, IT IS ORDAINED that Chapter 152-12 (C) and (D) are hereby amended in their entirety as set forth herein.

C. Solid waste and/or refuse collection receptacles shall be placed roadside or curbside by the beginning of the scheduled collection day as published on the Township website but not prior to 4:00 p.m. of the day preceding the day of collection, and shall be removed no later than the day of collection.

D. Except as specifically permitted for collection, no occupant shall store or maintain solid waste and/or refuse containers in the front yard area. The violation of this provision shall constitute a public nuisance, and is necessary for the preservation of the public health, safety and general welfare.

IT IS FURTHER ORDAINED that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

IT IS FURTHER ORDAINED that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

IT IS FURTHER ORDAINED that this Ordinance shall take effect upon passage and publication in accordance with applicable law.


