

TOWNSHIP OF PEMBERTON
ORDINANCE NO. 2-2015

AN ORDINANCE OF THE TOWNSHIP OF PEMBERTON
AMENDING CHAPTER 34 OF THE CODE OF THE
TOWNSHIP OF PEMBERTON, ENTITLED 'OFFICERS AND
EMPLOYEES'

WHEREAS, Article II, Chapter 34-6 and Chapter 34-7 purport to provide for the appointment and term of the Municipal Tax Collector notwithstanding the provision therefore in Chapter 3-17 of the Pemberton Code; and

WHEREAS, Article II, Chapter 34-9 and Chapter 34-10 purport to provide for the appointment and term of the Municipal Finance Officer notwithstanding the provision therefore in Chapter 3-15 of the Pemberton Code; and

WHEREAS, Article II, Chapter 34-11 and Chapter 34-12 purport to provide for the appointment and compensation of a Hearing Officer appointed by the Township Council to hear employee disciplinary matters in contravention of the applicable provisions of the Faulkner Act, the law under which Pemberton Township operates.

NOW, THEREFORE, IT IS ORDAINED, by the Township Council of the Township of Pemberton, in the County of Burlington and State of New Jersey that Chapter 34 (entitled "Officers and Employees") of the Township Code is hereby amended solely as set forth herein, as follows:

1. Article II (Sections 34-6, 34-7, and 34-8) is hereby repealed and deleted in its entirety
2. Article III (Sections 34-9 and 34-10) is hereby repealed and deleted in its entirety.
3. Article IV (Sections 34-11 and 34-12) is hereby repealed and deleted in its entirety.

IT IS FURTHER ORDAINED, that if any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged by the courts to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provisions so adjudicated, and the remainder of the Ordinance shall be deemed valid and effective; and

IT IS FURTHER ORDAINED, that any ordinances or parts thereof in conflict with the provisions of this Ordinance are repealed to the extent of such conflict; and

IT IS FURTHER ORDAINED, that this Ordinance shall take effect upon passage and publication in accordance with applicable law.


